

ORDINANCE

A SPECIAL ORDINANCE PROVIDING FOR THE INCLUSION OF THE CITY OF MANITOU SPRINGS INTO THE PIKES PEAK LIBRARY DISTRICT, UPON THE AFFIRMATIVE VOTE OF THE REGISTERED ELECTORS OF THE CITY OF MANITOU SPRINGS TO AUTHORIZE A TAX LEVY

WHEREAS, the residents of the City of Manitou Springs believe that they are best served by having the City be included in the Pikes Peak Library District;

WHEREAS, said residents acknowledge that in the event the City of Manitou Springs is included in the Pikes Peak Library District, the Manitou Springs Public Library and the City of Manitou Springs will be subject to an intergovernmental agreement between the City of Manitou Springs and the Pikes Peak Library District that sets forth the rights, obligations, and responsibilities of the City and the Pikes Peak Library District; and

WHEREAS, said residents acknowledge that the City of Manitou Springs may not be included in the Pikes Peak Library District unless the registered electors of the City of Manitou Springs vote to approve the imposition of the Pikes Peak Library District's mill levy on all taxable real and personal property within the City of Manitou Springs.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MANITOU SPRINGS, COLORADO, THAT:

Section 1: The City of Manitou Springs is hereby included in the Pikes Peak Library District, subject to the terms and conditions set forth in an Inclusion Agreement to be entered into by and between the City of Manitou Springs and the Pikes Peak Library District, and on the condition that, at the November 6, 2012 election, the registered electors of the City of Manitou Springs, Colorado approve the imposition of the Pikes Peak Library District's mill levy on all taxable real and personal property within the City of Manitou Springs.

Section 2: This ordinance shall take effect five (5) days after final approval and adoption on second reading.
