II. TRAIL MAINTENANCE

1. Clarify role OSAC plays with trail care and development
2. Identify trails OSAC is charged with maintaining
3. Assign sections of trails to monitor using the trail maintenance checklist, consider annual process to complete trial checklists
4. Identify process to list and prioritize trail maintenance projects / needs based on maintenance checklists (who will process checklists? and where will info be stored?)
5. Create a trail maintenance-type priority system (repair tread, clear brush, repair water drainage features, close off social trails, etc.)
6. Identify process / format to outline and explain trail maintenance projects needed
7. Prepare list of volunteer groups and companies OSAC could hire for projects, including lead contacts
8. Outline procedures for closing off and restoration of social trails adjacent to Manitou Trails maintained by OSAC
9. Discuss proposed Aug-Sept maintenance by Manitou CATS for gully on West Intemann trail just east of the Red Mountain Trailhead.
10. Discuss restoration project for the 2019 West Intemann re-route.
